Re: June 2023 Revenue Estimates

Dear Mayor Bowser and Chairman Mendelson:

This letter certifies that the revenue estimate for the FY 2023 – FY 2027 District of Columbia Budget and Financial Plan is unchanged from February 2023.

Revenue collections through May show that FY 2023 revenue is on track to meet the February forecast. Lower than expected estimated and final payments from individual income and unincorporated business taxes were largely offset by stronger than expected receipts from restaurant and hotel sales taxes and revenue from interest income.

The revenue forecast for the outyears is also unchanged as the economic outlook remains unchanged since February.

At the national level, risks to the forecast include a US recession triggered by further monetary tightening by the Federal Reserve and a federal government shutdown if no spending bill is reached, which could disrupt the local economy and reduce sales tax revenue related to tourism. District-specific risks include further expansion of remote work, an accelerated decline in federal employment, and a stalled population recovery.

We will continue to monitor international, national, and local economic activity for any developments that would change the forecast. If you have any questions regarding these matters, please contact me at (202) 727-2476.
